September 25, 2023

The Council met in the Union Bridge Town Hall, on Monday, September 25, 2023 at 7:00 p.m., for their monthly council meeting. Councilmember Laura Conaway motioned to approve the August 2023 operating statements, August 28, 2023 council meeting minutes, August 28, 2023 closed session minutes, the September 11, 2023 work session minutes and Quantum's financial statements for August 2023. MAYOR'S REPORT

- -Antietam Broadband will be starting underground work at Shriner Court.

- -Trick or Treat for Union Bridge will be Tuesday, October 31, 2023, between 6:00 p.m. and 8:00 p.m.
- -Mayor Jones stated that Cindi Emerick thanked Mayor and Council for guiding her to the correct person at Quantum Real Estate Management to speak to concerning an issue with documentation needed for Shriner Court.
- -Mayor Jones would like everyone to take time and educate themselves on how to prepare their household when there is a weather event that could result in power outages, travel restriction etc. Mayor Jones is working on putting together a letter listing things that every household should have in case of a weather emergency.
- -Ms. Terry Smack has sold Terry's Tag and Title and the Union Bridge location has been closed.

ATTORNEY REPORT - MANDI PORTER

- -Ms. Porter updated Mayor and Council on the PFAS litigation. 3M has reached a preliminary approved settlement with the full settlement approval to be expected in February 2024. The litigation team is asking for the Town to fill out the plaintiff fact sheet and forward it back to them by the end of this week.
