SPECIAL PROJECTS

Enjoy the New Playground at the Community Park

The old playground equipment on Ladiesburg Road (near the Community Center) has been replaced. The town received \$30,000 in funding from the Maryland Department of Natural Resources to install new swings, spring animals, seesaws, a climbing dome, and other park amenities. Please visit and enjoy the new playground with your family.

Park Rules & Regulations

The Mayor and Town Council are reviewing rules and policies for the use and safety of all town parks and recreational facilities. Topics under consideration include signage, safety, hours of operation, graffiti, animals, disposal of trash, etc. Penalties for illegal activities will also be reviewed.

Water Treatment Plant

Conewago Enterprises from Hanover PA has been selected the apparent low bidder for construction of the new Water Treatment Plant on West Locust Street. The facility will cost approximately \$1.26 M. Construction is expected to begin in July 2003.

Main Street (Rt. 75) Revitalization Work Set to Begin July 2003

The Maryland State Highway Administration (SHA) will fund a \$2.5 M improvement project for Main Street, from the bridge over Little Pipe Creek to the town limits near the Brethren Church. The SHA has selected Ross Contracting from Mt. Airy to complete the Main Street improvements. SHA funded work includes storm drainage, inlets, sidewalks, curb, gutter, pedestrian lighting, traffic control and signalization at Main and Broadway, resurfacing Main Street, signage, landscaping, and other improvements.

The project will be coordinated with the town's CDBG program, a \$220,000 grant from the Maryland Dept. of Housing and Community Development. The town's grant will cover other improvements not funded by SHA including upgrades to town side streets, new parking meters, burying overhead utility lines at Main and Broadway, (electric and cable wires), and a parking area at the entrance into Little Pipe Creek Park and trail (next to the car wash).

In addition, the town will be installing an 8" water line at this time. This is a continuation of the town's comprehensive water improvements program partially funded through the Rural Utilities Program, USDA.

The above-mentioned improvements are major in nature and will take almost a year to complete. Please consider what impact the construction activities along Main Street will have on your home or business. The town will be meeting with the SHA, Ross Construction, town engineer (and others), during the next few weeks to review the phasing and sequence of construction. We understand at this time that construction will start at the south end of town near the Rt. 75 bridge over Little Pipe Creek, and will involve storm drain systems, the 8" water line, work at the RR crossing, and other items. After the underground infrastructure is installed, the contractor will then work block-by-block to install the new patterned sidewalk, curb, gutter, streetlights, etc. Please contact the SHA District 7 Engineer with questions or complaints, or contact the town office and we will try to address your concerns with the State.

WEST NILE VIRUS

West Nile Virus is transmitted from infected birds to mosquitoes during feeding. Some birds become ill and die while others show no clinical symptoms of the disease. Approximately 10-14 days after contact with an infected bird, the mosquito becomes infected and can transmit the virus to humans, dogs, cats, horses and other animals.

Most people that become infected with the virus have no symptoms, while others can show mild symptoms that include fever, headache, body aches, skin rashes, and swollen lymph glands. In very few cases, severe symptoms and death can occur.

West Nile Virus has been detected in 138 bird species, particularly in crows and jays. There is no evidence that a person can get the virus from handling live or dead infected birds. Use gloves or double plastic bags to place dead bird in garbage bag for disposal. If you have any questions. Contact the Carroll county Health Department at 410-876-1884.

To minimize mosquitoes from inhabiting your area:

*clean out rain gutters

*remove old tires

*turn wading pools upside down

*pick up toys from yard that may retain water

*check for water on plastic tarps

*turn over flower pots and plastic containers

*store canoes & boats upside down

*replace water in birdbaths twice a week

*flush livestock water troughs twice a week

*keep lids on trashcans

*repair outside water faucets

*repair screens

*avoid areas of high mosquito infestation
*use mosquito repellants
*restrict outdoor play when mosquitoes are present

CITIZEN'S ALERT

Please notify the Sheriff's department if you see any activity around a town manhole or sewer clean out. Illegal septage dumping is occurring on an irregular basis. This activity is costly to you because the septage must be removed from the town's WasteWater Treatment Plant. The cost for this is usually between \$400 and \$800 depending on the amount of septage dumped.

Your help is needed to put a stop to this practice. It is most probably occurring at night and in a secluded area and is accomplished in a very short amount of time. Please keep your eyes and ears open and if you suspect something is not what it should be, call the Sheriff's Department at 410-386-2900.
