#### FROM THE MAYOR'S DESK

Soon we will begin construction of the new Water Treatment Plant, which will be located next to the Town Hall. The need for filtration came about when the Maryland Department of the Environment determined our well to be under the influence of surface water. This means that water from the surface is finding it's way into the well much too quickly. Normally the earth filters out any impurities as the water makes it's way slowly into the groundwater supply.

We add chlorine to the water as it is pumped out into the system as a means of disinfection. Chlorine is very effective at this task, but there are a few things it doesn't work well on, such as cryptosporidium or giardia. These things are larger than bacteria and have a hard shell which chlorine has a hard time penetrating. Luckily though for us, they can be caught by filter media such as sand, diatomaceous earth, membrane or the man-made ceramic media that we plan to

use. The Kinetico system we are installing was pilot tested on our main well and the one on the Fire Department property. Both sites tested very well and were approved by MDE.

There is also the problem of nitrate in the water. The EPA's maximum contaminant limit for nitrate in drinking water is 10 milligrams per liter. Our well is always between 9 and 10. It is MDE's wish that we install equipment to remove most of the nitrate, reducing the level to about 4.5 mg/l. This equipment is expensive to install and because of the salt required in the process, which is similar to the softening of water, makes the operational costs higher too.

All of the changes we have made to the water system are an effort by the Council to try and catch-up after years of neglect. I know the rate increase is not a popular decision by everyone, but we feel it is the only way to continue to provide an adequate supply of good potable water to all. If you look at what water actually costs I think you will be surprised at how inexpensive it really is. My family uses on average about 8500 gallons of water a quarter. That breaks down to about \$4.50 per thousand gallons. The more water you use, the cheaper it becomes due to the base rate. This also doesn't include the cost for sewer, which is another story. What else could you buy that cheaply? So I ask you to please support us as we make these tough decisions, because we all want what is best for Union Bridge.

# **MOSQUITO CONTROL**

The Department of Agriculture will spray for mosquitoes again this year. You are asked to help eliminate mosquito-breeding areas. Empty any standing water and keep fresh water in swimming pools. Use caution when disposing of dead birds or animals by wearing gloves.

Information on dates and times for spraying will be posted.

#### POOL FILL UP

Permits to fill pools from a fire hydrant may be picked up at the Town Hall during business hours. The permit must be brought to the Fire Department when requesting water and returned to the Town Hall for payment when complete. The cost for water is \$2.00 per 1,000 gallons of water used.

Thank you for your cooperation. The town's water supply is everyone's responsibility.

# WATER METERS

It is unlawful to tamper with or interfere with a water meter. WATER TURN OFF OR ON MUST BE DONE BY PERSON OR PERSONS DULY AUTHORIZED BY THE TOWN OR AN EMPLOYEE OF THE TOWN ONLY. Violators shall be guilty of a misdemeanor and shall be subject to a fine of not less than \$250.00 nor more than \$1,000.00 per violation.
