## FROM THE MAYOR'S DESK

We hope that by the time you read this, the paving will be finished on Main Street. I would not have believed that milling the surface would make it worse, but it did. The sidewalks are nearly finished and the traffic and street lights are being installed now. Before long the mess will be just a memory, and we will have a fine new street to show all. Again, thanks to everyone for their patience throughout this project, and a special thanks to the members of the Main Street Committee for their dedication and perseverance in seeing this through. Were it not for their finishing the groundwork when they did the project would have been lost due to budget cuts at the state level. They have done a wonderful job, which is becoming apparent with every passing day.

There may be some bad news on the way in the form of increased electricity costs to the Town. This is because of the deregulation of the electric industry, and will affect us all as a town and individually. We are presently working with a larger group of users brought together by the Chamber of Commerce in an effort to secure a lower price for electricity. The Town uses a lot of power to produce drinking water and treat wastewater as well as for street lighting. Higher oil prices and severe weather has driven the projected costs for power much higher than expected. We should know more by the end of October.

The town wishes to congratulate Corporal Cromwell on becoming a member of the Carroll County Crisis Response Team, a unit that is capable of handling high-risk hostage and barricade situations. #### **BAY RESTORATION FUND**

On May 26, 2004, Governor Ehrlich signed into law Senate Bill 320, which established the "Bay Restoration Fund". This legislation requires owners of wastewater treatment plants to collect \$2.50 per month per equivalent dwelling unit (EDU) from their users, effective January 1, 2005. The Bay Restoration Fund fees collected are to be deposited with the State Comptroller by the 20<sup>th</sup> day after each calendar quarter. The first payment is due by April 20, 2005.

The Town of Union Bridge bills quarterly for its water and sewer; therefore \$7.50 must be collected each billing period and deposited with the state for every residential and non-residential EDU. The water bills will have a line identifying the charge as "Bay Restoration Fee". Billing for non-residential sewer customers: the Town must calculate the average daily flow based on metered water, using 250 gpd as an average EDU. Example: if the average daily flow were 1,000 gallon, the "Bay Restoration Fee" would be \$30.00 per quarter, based on four EDU (1,000/250).

The fee will be a separate line item on the water/sewer bill and posted into a separate account. At the end of each quarter, the amount shown in the "Bay Restoration Fee" account will be transferred to the state.

MAIN STREET, SOUTH AND NORTH IS A SNOW EMERGENCY ROUTE WHICH MEANS THAT NO PARKING IS ALLOWED WHEN THE SNOW EVERGENCY PLAN IS IN EFFECT.
