-Ms. Conaway meeting with Shriner Court residents was canceled and will be rescheduled.

-Ms. Conaway received complaints about two (2) vehicles that are parked on W. Broadway and are never moved.

#### **AMY KALIN**

-Ms. Kalin had one (1) phone call related to water and sewer since the last Town work session.

-Ms. Kalin received complaints about the condensation in the parking meters.

#### CHERI THOMPSON

-Ms. Thompson inquired about using the Community Center dumpster for the trash that will be generated from the Duck Derby. Ms. Thompson stated that Dream Big Union Bridge would be happy to make a donation to the Town for the use of the dumpster. Mayor and Council are concerned if there would be enough room in the dumpster if someone was to rent the center on that same weekend. Ms. Thompson will check with the Town closer to the event date to see if using the Community Center dumpster is an option.
