FROM THE MAYOR'S DESK

I would like to say I have good news and bad news, but unfortunately I have only bad news. The Town is feeling the pinch of the nationwide recession and as there seems to be no end in sight we will need to adjust our budget to address some shortfalls in revenue. The most crushing loss in revenue came from the State in the manner of reduced Highway User Funds. These funds were reduced 90%, which means we have very little money to repair the streets or for snow removal. There are some projects that we have signed contracts for that will be completed, but nothing else will be done until this issue with the State is resolved. I still hold out hope that they will relent and give the counties and municipalities at least 50% of budgeted amounts. That would at least allow us to do some street maintenance and provide for snow removal. The Town Clerk has done a great job of identifying areas within the budget that can be reduced with little or no impact to the rest of Town services, but street maintenance will be a problem for the foreseeable future. We will keep you posted and let's hope for a mild winter

Grant Project Update
Farquhar Street Sidewalk Improvements -

Construction has begun on the Farquhar Street Sidewalks. All the residents on Farquhar Street will be given a notice letter as to when the construction will begin on their block. In these notice letters, MK Concrete Construction will have a small list of suggested items not to use on the sidewalk this winter. Union Bridge would like to keep the sidewalks looking as nice as possible for as long as possible. The town received a \$195,300 grant from the Community Development Block Grant (CDBG) toward the sidewalk improvements.

South Benedum Street Sidewalk Improvements -

The Town of Union Bridge was awarded \$242,000 from Maryland's Department of Housing and Community Development's Community Development Block Grant Program. This grant will be used to improve sidewalks and curbing along South Benedum Street. This will be at no cost to the residents or property owners.

The Union Bridge Youth Committee, the Carroll County Public Library and The Town of Union Bridge are pleased to announce the opening of a free community computer lab, with Wi-Fi Internet service, at the Union Bridge Community Center on Ladiesburg Road most Mondays, Tuesdays and Thursdays from 5 PM to 9 PM. In addition, the Carroll County Public Library Bookmobile will visit the center every other Monday from 5:30 to 7:30.

The computer center currently has six computers with Internet access, which visitors may use for online sessions of up to an hour. Two additional computers will be available for offline activities, such as computer training, educational software, and other activities. Visitors may also bring their own computers and access the Internet with the free Wi-Fi signal. Additionally, students may come to the center to get help with their homework, both online and offline, from volunteers. Students who wish to earn volunteer credit hours may be eligible to do so by serving the center and showing people how to use the computers.

The center has been established using private donations, including contributions from the Lehigh Heidelberg Portland Cement Company, the Union Bridge Lions Club, the Megan Taylor Foundation and Wayne and Betty Adams.

News Release

A public hearing on Amendment to the Union Bridge Comprehensive Plan is set for November 19th. The 60-day public review and comment period for a proposed amendment to the "2008 Union Bridge Community Comprehensive Plan" ends on November 6, 2009. This amendment proposes to delete from the transportation element

the proposed future extension of Shepherd's Mill Road from its existing terminus at Quaker Hill Road westward to MD Route 75/Green Valley Road. This component of the Comprehensive Plan is shown as a planned major street and would be eliminated from the Plan altogether by the proposed amendment. Any supporting text in the Comprehensive Plan would likewise be deleted or modified consistent with the amendment.

The final step in the public comment process will be the public hearing on the plan, which is slated for Nov. 19, 2009 at 6:30 p.m. at the Union Bridge Town Hall, 104 West Locust St., Union Bridge, MD.

The public hearing provides an opportunity for citizens to influence the future of Union Bridge by submitting written or oral comments on the amendment to the comprehensive plan for the town and its surrounding area. The proposed amendment may be modified as a result of the comments received during the public review period.

Copies of the proposed revised plan map are available for review at the Town Hall, any Carroll County Public Library branch, the County Dept. of Planning and may also be reviewed on the Carroll County Government web site:http://ccgovernment.carr.org/ccg/compplan/unbridge/default.asp.
