

THE TOWN OF UNION BRIDGE
WORK SESSION
October 16, 2023

The Council held a work session meeting on October 16, 2023, at 6:30 p.m., in the Town Hall. Notice of the meeting was given by posting the agenda at the Town Hall, on the Town's website, and provision to the Carroll County Times. Those present were Laura Conaway; Cheri Thompson; Amy Kalin; and the Town Clerk/Treasurer Dawn Metcalf. Mayor Perry L. Jones Jr.; Ellen Cutsail; and Bret Grossnickle were absent.

MISCELLANEOUS DISCUSSION

-Mayor Jones and Clerk-Treasurer have discussed in detail to remove \$750,000.00 out of the general savings account and place it in an 8-month CD at an interest rate of 4.71% with a 4.80% yield that PNC has to offer. Everyone was in agreement to remove \$750,000.00 out of the general savings account and deposit in a PNC Bank CD offering an interest rate of 4.71% with a 4.80% yield. Clerk-Treasurer is authorized to proceed with transaction.

-On October 19th one of Union Bridge's CD's with ACNB Bank will mature. The amount of this CD is \$105,966.01. Mayor Jones and Clerk-Treasurer Dawn Metcalf would like to cash it out of ACNB and open an 8-month CD at PNC that is offering 4.71% with a 4.80% yield. Everyone was in agreement to cash out the \$105,966.01 CD at ACNB and to open an 8-month CD at PNC offering 4.71% interest with a 4.80% yield. Clerk-Treasurer is authorized to proceed with transaction.

-Discussion on changing election procedures/regulations. Everyone was in agreement to table this discussion until the November work session.

LAURA CONAWAY

Ms. Conaway stated that we need to appoint two new private citizens to the Disorderly House Abatement Committee to replace Ellen Cutsail and Bret Grossnickle who were elected to council in May of 2023. **Councilmember Laura Conaway motioned to appoint Sheryl Russell to the private citizen list for the Disorderly House Abatement Committee. Councilmember Amy Kalin seconded and the motion passed unanimously.** Ms. Conaway is still looking for another person to fill the vacant position.
