GRANT PROJECTS UPDATE Wetlands Park Trail Extension

The Town of Union Bridge has been awarded grant funding from Maryland Program Open Space and Maryland Community Parks and Playgrounds programs for the planned final phase of the trail system in the town's Wetlands Park located off of RT. 75. The town plans to start the project in the spring of 2015. Once complete, the trail will "loop" around the park for a distance of approximately one mile.

USDA Vehicle Truck Purchase

The Town of Union Bridge has been awarded a grant from the United States Department of Agriculture for \$37,500 for the purchase of a multi-purpose municipal vehicle for town use. The town has received multiple price quotes from local

dealers and will make a decision in December based on the lowest quote.

Maryland Energy Administration Backup Generator

Union Bridge completed a grant application to the Maryland Emergency Management Agency for the purchase and installation of an emergency backup generator for the Town's Water Treatment Facility.

THINGS YOU SHOULD KNOW ABOUT TOWN ELECTIONS:

Voter Registration: It is necessary to be registered in order to vote in Town elections. If you are already registered with the County to vote in County, State, and Federal elections, you are automatically registered to vote in Town elections. If you wish to vote in only the Town election you may register at the Town Hall during regular hours, 8 a.m. to 4:00 p.m. Monday through Friday. **Registration will close on Saturday, April 11, 2015 at 4:00 p.m.**

Qualification of voters:

- 1. You must be a citizen of the United States.
- 2. You must be at least eighteen (18) years of age on or before Election Day.
- 3. You must have resided within the corporate limits at least thirty (30) days prior to the election.
- 4. You must be registered to vote.

Qualification of Candidates for Mayor and Council:

- 1. You must have resided within the corporate limits for at least one (1) year.
- 2. You must be at least eighteen (18) years of age.
- 3. You must be a qualified voter of the Town.

Terms of office are for four (4) years

A candidate for office must file a "Certificate of Nomination" with the Town Clerk, no later than 4:00 p.m. on Monday, April 13, 2015.

WINTER MAINTENANCE AND CARE OF PATTERN SIDEWALKS

- 1. Sand or kitty litter may be used for traction.
- 2. Snow removal equipment should have a rubber edged blade.
- 3. We do not recommend the use of salt or snow melting product containing sodium chloride. In the event that these products must be used wash any residue from the concrete surface when feasible.
- 4. Avoid the use of ice picks or anything that may chip or damage the concrete surface.

REMINDER: UNION BRIDGE CODE CHAPTER 130, SEC. 4 (B2)

Owners or occupants of premises fronting on any street with paved sidewalks shall remove any snow or ice from the traveled portions of the sidewalk, to a width of at least 30", within 24 hours after snow or ice ceases to fall.

SNOW

Main Street is a snow emergency route.

NO PARKING is allowed when the snow emergency plan is in effect.

NO PARKING on East Broadway from Lightner Street up to Bellevue and on Thomas Street up to Bellevue when the snow emergency plan is in effect.
