SPECIAL PROJECTS

Extra Lighting Planned for the Community Park

To better illuminate the Community Park and playground equipment, the town was awarded a \$30,000 grant from Maryland Program Open Space. The extra lighting should reduce vandalism and park graffiti. Funds will also be available to install a new fence around the tennis courts. Parking will also be improved near the entrance to the playground. Construction should begin in the spring of 2004.

Water Treatment Plant

A contract was approved with Conewago Enterprises from Hanover PA for construction of the new Water Treatment Plant on West Locust Street. The facility will cost approximately \$1.26 M. Construction and mobilization began in late August 2003.

Main Street (Rt. 75) Revitalization Work Set to Begin in July 2003

Ross Construction Inc. (from Mt. Airy), has mobilized to begin improvements for Main Street. The Maryland State Highway Administration (SHA) will fund a \$2.5 M improvement project for Main Street, from the bridge over Little Pipe Creek to the town limits near the Brethren Church. SHA-funded work includes storm drainage, inlets, sidewalks, curb, gutter, pedestrian lighting, traffic control and signalization at Main and Broadway, resurfacing Main Street, signage, landscaping, and other improvements.

The project will be coordinated with the town's CDBG program, a \$220,000 grant from the Maryland Dept. of Housing and Community Development. The town's grant will cover other improvements not funded by SHA, including upgrades to town side-streets, new parking meters, burying overhead utility lines at Main and Broadway, (electric and cable wires), and a parking area at the entrance into the Little Pipe Creek Park and trail (next to the car wash). The town has hired Stambaugh's Inc. to complete the parking lot improvements. Construction should begin in late fall 2003.

In addition, the town will be installing an 8" water line at this time. This is a continuation of the town's comprehensive water improvements program partially funded through the Rural Utilities Program, USDA.

The above mentioned improvements are major in nature and will take almost a year to complete. Please consider what impact the construction activities along Main Street will have on your home or business. The town will be meeting with the SHA, Ross Construction, town engineer (and others), during the next few weeks to review the phasing and sequence of construction. We understand at this time that construction will start at the south end of town near the Rt. 75 bridge over Little Pipe Creek, and will involve storm drain systems, the 8" water line, work at the RR crossing, and other items. After the underground infrastructure is installed, the contractor will then work block-by-block to install the new patterned sidewalk, curb, gutter, streetlights, etc. Please contact the SHA District 7 Engineer with questions or complaints,or contact the town office and we will try to address your concerns with the State.

LOCAL WALKING TRAILS BY MARYLOU STONE

LITTLE PIPE CREEK PARK WALKING TRAIL

If you are into finding different birds, this is the trail for you. I spotted the following: Cedar Waxwing, Willow Flycatcher, Orchard Oriole, both male and female Red Wing Blackbirds, American Kestrel (he was actually sitting on the electric wire with a mouse in his claws), Red Bellied woodpecker, Goldfinch, Eastern Phoebe, Mockingbird, Robin, Song Sparrow, House Sparrow, Chimney Swift, Barn Swallow, and Tree Swallow. All of these birds were spotted within one hour.

To find this trail take Md. Route 26 east from Frederick to Libertytown. Then take Md. Route 75 north to Union Bridge. The trail begins on the right-hand side of Md. Route 75, next to the car wash. There is parking available for about three cars at the trailhead, or you can park at the Western Maryland Railroad Museum, which is open on Sundays from 1 p.m. until 4 p.m.

The trail is paved, so it is perfect for either strollers or wheel chairs. The trail is about one-half mile long, or round trip, a mile. It passes through a wetland that had a very sweet smelling flower blooming, and crosses over Little Pipe Creek. Be on the lookout for

deer. I spotted one jumping across the park even at midday.
